

APEGA Gift Guide 2021: CONTEST RULES

APEGA Gift Guide 2021 Contest

Contest Period

Nov. 24, 2021, at 9 a.m. MST to Dec. 7, 2021, at 11:59 p.m. MST

Description of Prizes

There will be a total of 12 winners, four from each age range as listed in the *APEGA Gift Guide 2021*. Each winner shall receive one toy from the gift guide as chosen by APEGA, based on the child's age submitted by the contestant.

How to Enter

No purchase required. To enter the contest, readers must find and submit one of four locations of Gus, the APEGA dinosaur (illustrated on the inside cover of the *APEGA Gift Guide 2021*), during the contest period. Answers must be submitted online at apega.ca/giftguide and the submission must include the contest registrant's name and email address, along with the child's first name and age. Contest entries must be received by 11:59 p.m. MST on Dec. 7, 2021.

Limit of one entry per person per day. If an individual attempts or is suspected of attempting to enter more than once per day, or to use robotic, automatic, programmed, or any entry methods not authorized by these rules, it shall be deemed as tampering and will void the individual's entries.

Eligibility

Residents of Alberta who are 18 years of age or older at the contest opening date and who have submitted one of the four correct page numbers (6, 11, 12, and 18) on apega.ca/giftguide are eligible to enter the contest.

APEGA staff members are not eligible to participate.

A registrant is not able to win more than once.

Procedure for Awarding Prizes

APEGA will conduct a random draw from all eligible entries on Dec. 8, 2021. There will be 12 winners total—four per each age range listed in the gift guide (1–4, 5–10, and 11+). Each winner will be awarded one toy from the *APEGA Gift Guide 2021* as chosen by APEGA Communications and based on the child's age as submitted by the contestant.

Winners will be notified by email between Dec. 9, 2021, and Dec. 10, 2021, at the email address they used to register for the contest.

General Rules

1. A mathematical skill-testing question must be answered to win the prize.
2. The winner must claim the prize no later than seven days after the date they are initially contacted. If a winner cannot be reached within seven days, incorrectly answers the skill-testing question, does not claim the prize, or declines the prize, APEGA has the right to select another winner.

3. The prize shall be accepted as-is and may not be exchanged or refunded for an amount of money, sold, or transferred. No substitutions are allowed. Any unused portion of a prize will be forfeited.
4. If the prize cannot be awarded as described in these rules, APEGA reserves the right to substitute a prize or prize component with another of comparable value.

6. If the identity of a winner is disputed, the authorized account holder of the email address will be deemed to be the winner. The individual assigned to the email address for the domain associated with the submitted email address is considered the authorized account holder. A winner may be required to provide proof they are the authorized account holder of the email address associated with the selected entry.
